MINUTES OF THE MEETING HELD ON 15.05.2023 at 03.00 PM

A meeting to discuss greening/ plantation action plan for the year 2023-24 in NCT of Delhi and NCR districts of Uttar Pradesh, was held on 15.05.2023 under the Chairmanship of Dr. N. P. Shukla, Member Technical, CAQM. A list of participants is **Annexed**.

2. Director, CAQM welcomed the participants of the meeting. He requested the coordinating department/ officer to present the targeted action plan for the year 2023-24.

UTTAR PRADESH

3. Shri Ganga Prasad, Conservator of Forest, Meerut presented the greening and plantation action plan of Uttar Pradesh for 2023-24 as under:

4. It was noted in the meeting that Uttar Pradesh have set the plantation target of 1,52,35,058 for 2023-24 which is only 81% of the plantation target for previous year.

5. Shri Ganga Prasad, Conservator of Forest, Meerut submitted concern over land availability in the NCR districts of UP, due to diversion of land from NCR districts of UP to Non-NCR districts of UP under CAMPA. It was also noted that the target of Other Departments for the year 2023-24 includes YEIDA and Irrigation Department.

6. Shri N. P. Shukla, Member Technical, CAQM emphasized on land identification for greening and plantation including area for dense plantation, gap filing and restoration of degraded land/ abandoned mines.

7. As per the deliberations held in the meeting, targets of the following agencies have been revised upwards and needs to be incorporated in the action plan for NCR districts of UP:

8. Shri N. P. Shukla, Member Technical, CAQM reiterated to the representative of the State Government of UP that the data should be submitted only in the format which is in practice for last one year. A copy of the format was again given to the CF, Meerut.

9. CF, Meerut, submitted that extensive greening of fly ash area have been previously undertaken and that program for succession plantation is being devised.

10. State Govt. of Uttar Pradesh need to reconcile their data and submit updated data to the Commission by 31.05.2023 in the provided format.

GNCTD

11. Shri Amit Anand, DCF, Forest Department, presented the greening and plantation action plan for increasing the green cover in Delhi for 2023-24 as under:

12. It was noted that GNCTD have set the plantation target of 95,04,390 for 2023-24, which is 198% higher than the plantation target of the previous year, in addition to 7,00,000 free distribution of saplings.

13. As per the deliberations held in the meeting, targets of the following agencies have been revised upwards:

14. Representative of NDMC informed that they have already achieved the plantation target of 5 Lac fixed for the financial year 2023-24 and plan to enhance their target up to 50 Lac in light of G20 preparations for the year 2023-24.

15. Shri Amit Anand, DCF informed that they will keep track of free distributed plants so that their actual plantation can be assured and that a portal for the same is underway.

16. After detailed discussions in the meeting the following decisions were taken:

- I. The concerned nodal Department (Environment & Forest) of Government of Uttar Pradesh and GNCTD will submit status of their plans keeping in view the issue highlighted above and sent it to the Commission by 31.05.2023.
- II. The concerned nodal Department of Environment/ Department of Forest of respective State Governments to provide a consolidated write-up highlighting the various schemes and achievements of the plantation and greening programme in the respective NCR districts for the year 2022-23 along with high-resolution Sample photographs screened by the State Representatives to the Commission by 30.05.2023.
- III. Next meeting in this context will be held shortly.

17. The meeting ended with a vote of thanks to the Chair.
