MINUTES OF THE MEETING REGARDING REVIEW AND DISCUSS THE PLANTATION ACTION PLAN OF ALL THE GREENING AGENCIES UNDER GREEN ACTION PLAN 2023

A meeting was held under the chairmanship of the Pr. Chief Conservator of Forests, GNCTD on 12.06.2023 at 09.30 AM via VC to review and discuss the plantation action plan of all the Greening Agencies under Green Action Plan 2023.

The meeting was attended by representatives of various greening agencies of Delhi, viz., DDA, MCD, NDMC, Education Department, DSIIDC, NTPC, DJB, I&FCD, NHAI, BSES Rajdhani (BRPL), CPWD, DMRC, Horticulture Department and DTC.

At the onset of the meeting, DCF (P&M) conveyed that vide minutes of meeting dated 15.05.2023 held under the chairmanship of Member Technical, Commission of Air Quality Management in NCR and Adjoining Areas the annual plantation target of the Govt. of NCT of Delhi has been revised and the plantation target under Green Action Plan 2023 has been increased to 95,04,390 and free distribution target to 7,00,000.

In view of the above, agency wise plantation target and plantation location details were discussed as presented below:

In view of the above following discussions and decisions were made:

- 1. The agencies who are yet to share the plantation location details were requested to share the same within 2 weeks, i.e, before onset of Monsoon season (w.e.f 01.07.2023).
- 2. DDA, DSIIDC, I&FCD were raised the issue of lacking of space for carrying out tree plantation. All are requested to opt for more ground cover and innovative plantation techniques, such as high density multilayered plantation, miawaki, vertical gardening, eco-restoration etc.
- 3. DMRC was requested to explore the possibilities for potted plantation of flowering plants at metro stations to increase the greenery of the city and to enhance the aesthetic value of the metro stations of NCT of Delhi.

- 4. MCD was requested to arrange for a demonstration of miawaki technique being implemented by them on request received from various departments. MCD agreed provide the same as and when requests are received.
- 5. It was emphasized to follow the given species composition for plantation during the year 2023:
 - Plantation of **native/indigenous** species (Annexure-I): 60 %
 - Plantation of **fruiting** species (Annexure-II): 25 %
 - Plantation of **flowering** species (Annexure-III): 15 %
- 6. PCCF was asked all the agencies to give importance to the size and quality of seedlings which are to be planted so that good survival rate can be ensured.
- 7. The timeline of Green Action Plan 2023 as discussed vide meeting dated 21.02.2023 held under the chairmanship of Hon'ble Minister (E&F), GNCTD is from January 2023 to December 2023, divided into Summer Action Plan (April 2023 to September 2023) and Winter Action Plan (January 2023 to March 2023; October 2023 to December 2023).
- 8. DCF (P&M) conveyed that a dedicated portal on Green Action Plan has been created by the Department of Forests and Wildlife, GNCTD to record and monitor the progress of greening measures being undertaken by the GNCTD. A training session for the same to be organized on 21.06.2023 (Wednesday) by the Department.
- 9. Absence of agencies like Northern Railways, Delhi Cantt., Higher Education, DUSIB was noted.
- 10. The annual target of Green Action Plan 2023 which has been finalized vide meeting dated 21.02.2023 held under the chairmanship of Hon'ble Minister (E&F), GNCTD and vide MOM dated 15.05.2023 held under the chairmanship of Member Technical, CAQM is annexed herewith as **Annexure-IV**.
- 11. The meeting ended with thanks to the chair.
