**RECORD OF DISCUSSIONS OF THE MEETING HELD ON 06.07.2023**

A meeting to review the status of greening/plantation action plan for the year 2022-23 in Delhi held on 06.07.2023 under the chairmanship of Sh. N. P. Shukla, Member Technical, CAQM in physical mode. List of participants is annexed.

At the outset, Member Technical, CAQM welcomed the participants and informed that combined efforts of all the stakeholders resulted in massive plantation in Delhi and urged to move forward in progressive manner.

1. Shri Amit Anand, DCF, Forest Department, informed that a web portal is developed for monitoring of plantation activities in GNCTD. All the agencies will have to add plantation sites on the portal and update the status on monthly basis. Concerned agencies will have to upload KML file on the portal, so that geographical detail of plantation sites is available on real time basis for monitoring & reporting.
2. Sh. N. P. Shukla, Member Technical, CAQM, suggested that NDMC may organize event while undertaking plantation in large number and dignitaries may be invited in such events. Further, it was suggested to adopt Miyawaki technique to grow dense urban forest patches where smaller land area is available for plantation. The Chair emphasized that purposeful plantation resulting in decrease of AQI is need of the hour.
3. All the agencies were directed to provide below mentioned details on or before 10<sup>th</sup> July, 2023:
  - i. Plantation details for the year 2022-23.
  - ii. Plantation plan details of 2023-24 comprising of:
    - a. Plans for linear plantation i.e. roadside, central verges, etc.
    - b. Areas identified for block plantation in open space, parks, etc.
    - c. Plans for plantation in Educational institutions, R&D institutions, etc.

The meeting ended with a vote of thanks to the Chair.
