Minutes of Meeting

Subject: Minutes of meeting convened on 20.04.2023 under the Chairmanship of Hon'ble Minister (Environment), GNCTD regarding finalization of "Summer Action Plan 2023"

A meeting was convened on 20.04.2023 at 01:00 PM under the Chairmanship of Hon'ble Minister (Environment), GNCTD in Conference Room No. 3, Level- 2 at Delhi Secretariat GNCTD regarding the finalization of Summer Action Plan 2023. (List of participants is at Annexure A).

With due approval of the Chair, Special Secretary (Environment) gave a detailed presentation on the following 15 agenda points of Summer Action Plan 2023 highlighting the focused approach, progress update of Agencies/Departments and action plans proposed for the Summer 2023 under each points:

1. Dust pollution
2. Industrial pollution
3. Noise control
4. Water pollution and solid waste management
5. Tree Plantation Drive
6. Tree transplantation Policy
7. Real time Source Apportionment Study
8. Open Burning
9. Development of City Forest
10. Urban Farming
11. Development of Jheel/Ponds in Delhi
12. Development of Parks (Harit Park) in Delhi
13. E-waste Eco-park
14. Eco-Club Activities
15. Coordination with neighbouring state Government

During the meeting, Hon'ble Minister (Environment) directed that Solid Waste Management to be added separately as 16th agenda point under Summer Action Plan 2023.

After detailed deliberations and discussions, following decisions were taken by the Chair:

1. Dust Pollution:

- a) All the DC (MCD) to convene separate meetings with Project proponents and significantly ensure all C&D sites are onboarded on the web portal. Also, ensure online monitoring along with the physical inspection.
- b) The action on Inventorised major 10 air pollution sources in all hotspots to be ensured before Winter i.e., by September 2023.
- c) Saral App. of MCD under Ease of Doing business to be integrated by MCD with the C&D Web Portal of DPCC so that building plan cleared can be onboarded on C&D web portal.
- d) Renewed campaign on optimum deployment of MRS machines, water sprinkling machines and anti-smog guns to be launched by all construction agencies/departments.
- e) Anti-Dust Campaign to be launched in May, 2023.

2. Industrial Pollution:

- a) Joint team of DPCC and DSIIDC to be constituted to check illegal dumping of waste on vacant plots in industrial area.
- b) DSIIDC & MCD to prepare industrial waste management plan for industrial area and non-confirming areas respectively.

3. Noise Pollution:

A separate meeting to be called with all the stakeholder depts. regarding the implementation of Noise Pollution Control Action Plan.

4. Water Pollution

DPCC to monitor the action being taken regarding Water Pollution Control, upgrading of STPs, expansion of sewerage network, construction of new STPs, trapping of entrapped drain out falling into River Yamuna etc.

5. Tree Plantation Drive

During the implementation of Summer Action Plan, about 42 lakhs Trees/Shrubs to be planted by greening agencies and 4 lakhs saplings to be distributed free of cost. Forest department to ensure achievement of plantation and free distribution targets set by greening agencies under Greening Action Plan. Forest Department to organize Van Mahostav on Environment Day (5th June 2023) at an Indoor Stadium. Comprehensive Plan with Directorate of Education to be made for Citizen awareness along with a campaign to be initiated for the free distribution of plants.

6. Tree Transplantation Policy:

Forest department to inspect the sites and monitor survival of transplanted trees. Project wise guidelines should be issued to agencies seeking transplantation

permission for ensuring the survival of transplanted trees. Separate nodal officer to be appointed for enforcement of transplantation policy.

7. Real Time Source Apportionment Study

- a) DPCC to prepare deployment plan of mobile Air lab at all 13 hotspots and share the same with all the DCs (Nodal Officer hotspots) MCD along with the analysis report of the data on hotspots as recorded by the mobile van.
- b) All the DCs (Nodal officer hotspot) of MCD to monitor R-AASMAN website for fetching Real Time data with hourly variation and accordingly initiate action for air pollution control on ground.
- c) Round Table Conference to be organized on 15.05.2023 for sensitizing agencies on air pollution sources based on Real Time Source Apportionment Study report result.

8. Prohibition on Open Burning

- a) Separate Monitoring team of DPCC and MCD officer to be constituted to monitor landfill fires, SOP on landfill fire to be implemented.
- b) Enforcement agencies to ensure prohibition on open burning with special emphasis on spots with piled up dried leaves, plantation along floodplain area etc.

9. Development of City Forest:

Forest department to submit City Forest Concept Plan with details of activities to be undertaken.

10. Urban Farming

400 Urban farming workshops to be conducted with the objective to increase the green cover. Training Kit to be provided to the participants.

11. Development of Water Bodies

Ground truthing of 700 water bodies to be conducted. Restoration of about 100 water bodies to be done by land owning agencies.

12. Development of Parks

Financial assistance to be given to RWAs/NGOs for maintenance and development of parks and gardens in Delhi.

13. Development of E-waste Eco-park:

DSIIDC to expedite the establishment of E-waste Eco-park for management and disposal of e-waste.

14. Eco-club activities:

- About 2000 Eco Clubs of School/Colleges to be targeted for conducting Eco-Club Activities on awareness Ward Wise mapping of Eco-club Schools/colleges to be conducted.
- A core team of 10-20 eco-club teachers from active eco-club schools/colleges to be constituted.

15. Dialogue with Central Government and neighbouring states:

- Neighbouring states to be approached through DO letters on intervention required on following issues:
 - i. Conversion of Public Transport on CNG
 - ii. Air Pollution Control at Brick Kilns
 - iii. Air pollution Control from Thermal Power Plant in vicinity of Delhi.
 - iv. Discourage entry of non-destined trucks into Delhi
 - v. Preparation for controlling Stubble Burning

16. Solid Waste Management:

- Solid waste management to be added separately as 16th agenda point under Summer Action Plan 2023.
- DPCC to monitor the implementation of solid waste management plan with action taken regarding Municipal Solid Waste Management and Disposaa, Bio-mining of Legacy Waste at 3 dumpsites, Construction of one Engineered Landfill Site at Tehkhand, Construction 4 Decentralised Compost Plants (at Vishwas Nagar- 01 TPD, New Ashok Nagar- 01 TPD, Kirby Place Delhi Cantt.- 60 TPD and NDMC area- 08 TPD) and Construction of 02 Waste to Energy Plant at Nerala-Bawana (3000 TPD) and Ghazipur (2000 TPD) and expansion of existing WTE at Okhla (1000 TPD) etc.

The meeting ended with the vote of thanks to the Chair.






