CORAM: HON'BLE MR. JUSTICE NAJMI WAZIRI ORDER 07.07.2023

The hearing has been conducted through hybrid mode (physical and virtual hearing).

1. Mr. Satyakam, the learned ASC, GNCTD/Delhi Police states upon instructions that instead of 100 trees, the police officers have planted 120 saplings around Delhi Parade Ground. The photographs show that along the boundary wall of the Parade Ground, some trees which are not native to Delhi have been planted. It would be better for the Police Department to plant some more suitable indigenous trees such as (i) Pilkhan (ii) Kala Siris/Safed Siris (iii) Amaltas (iv) Pilkhan (v) Kachnaar, etc. Each tree shall have a minimum of three-years' nursery age and a trunk height of eight feet. Compliance affidavits, along with photographs showing the position both before and after the plantation, duly protected by tree- guards/fences, shall be filed both by the DCF concerned and the respondents before the next date.

- 2. The photographs filed along with the Status Report by the NDMC, in terms of the orders of this court in order dated 24.05.2023, show that the concrete around many trees at Aurobindo Marg has been removed and pits have been dug up for fresh plantation. The court is assured that the trees shall be tended to on regular basis. The assurance is accepted. In this regard, the assistance of Mr Tushar Sannu, the learned ASC, NDMC is much appreciated.
